# 3. New Business

# 3.1 Inclusion@Sport Presentation – Brooke Carter

Brooke provided an update on the Inclusion@Sport Project and consulted on engaging with sporting clubs and the types of programs that would be well received by people with disability.

#### **Discussion**

#### The key points regarding the Inclusion@Sport program raised were:

- Creating more sporting opportunities for people who have a disability
- Disability Awareness Training offered to sporting clubs
- Existing toolkit Sport4all
- Inclusion Action Plan
- 5 Clubs participating

#### Committee members raised the following feedback during the discussion:

- Ensuring that staff and volunteers at clubs are informed and understand the unique needs of each individual
- Understanding the motivation of the individual may not be about being competitive. Understanding why and how someone might want to participate
- Creating sporting opportunities which are not overwhelming
- Having an opportunity for new people to join through informal drop in sessions. Keeping in mind that
  people may attend with hesitation, sporting clubs should create an environment which makes people
  feel included and welcomed.
- Clubs could run a training day for people with a disability to get engagement (eg cricket day) to explain the rules and help people get involved
- Information sharing:
  - o A local banner could be created to share information
  - o Having a communication process to identify what different clubs are doing to promoted inclusion
  - o Closing the gap between finding information and clubs know how to disseminate information
  - Having links to clubs on the website could improve access to finding sporting clubs
- Clubs offering different options of sports
- Having the ability to contact peak bodies to improve inclusion in sport
- Improving access at venues and making sure clubs think and act on how needs can be accommodated for. This would also extend to being clear about who a club can cater for, to avoid disappointment.
- Clubs and participants should start with small goals to ensure long term succession
- A mentor program could be created
- Special development schools could run excursions to the sporting clubs
- Some people with disability may have a preference to play with other people with disability
- A Banyule Disability Inclusive cricket club could be formed.

#### Action

Action 1: Brooke to consider if Council would support people with a disability to establish a cricket club/ group.

# 3.2 Community Infrastructure Plan – presenter - Niki Efstratiou

Council is currently developing a Community Infrastructure Plan to develop investment priorities and actions over a 10-year period to meet current, emerging and future needs of Banyule. The community buildings within the scope of the plan include Libraries, Neighbourhood Learning Centres, Community Halls, Jets Youth Centre, Kindergarten, Maternal and Child Health, Childcare centres, Arts and Cultural Space and Sports Pavilions. Niki will be seeking community feedback on the plan (draft), who else to consult with, groups that may need to spaces to deliver services, activities and events and how to maximise usage of existing buildings. #### **Discussion:**

#### Key discussion points raised by Niki:

- 132 buildings some with services co-located Up to 95 non-council owned buildings but wanting to work in partnership to get community access so these are in the Plan.
- Seeking to work with non-council owned community building owners including churches, schools and scouts.
- To establish benchmark measures, Council is looking to provide community buildings that are fit for people (accessible), fit for purpose (well-designed) and fit for place (location).

#### Key priorities are to:

- 1. Make better use of existing buildings because groups are seeking access to more spaces to provide programs that help people connect.
- 2. Review lease and licencing agreements to enable multiple uses, especially of sporting pavilions
- 3. Upgrade buildings for children and youth, especially in line with 3 year-old kindergarten policy changes
- 4. Create clusters of buildings with complementary uses

#### **Emerging issues identified through consultation:**

- 1. Post-covid people realising the importance of social activities and events in sites close to home
- 2. Want to connect with activities and events in local area
- 3. Groups want to expand their services and programs but need more space
- 4. More accessible information on how to book facilities (bookable on line).

Niki asked the Committee to comment on ways to make buildings more accessible.

#### **Key points discussed included:**

- Council should not charge for use of buildings make it free, cost is a barrier for participation.
- Online booking system should be optional some people don't like this option, prefer to speak to a person
- Trying to find a venue for events should be available in different formats, recognising that people absorb information in different ways. For example, the information on Bellfield Community Hub is too much and confusing.
- Buildings should have disability parking available/close by.
- It would be beneficial to know the availability of facilities and when they are being used (i.e sporting clubs training)
- Having assistance from Council Staff– recognising that having an internal contact can support the process.
- Accessibility should be holistic i.e. close to public transport, location of entries and exits
- Site/building maps aren't aways useful video might support better
- Maintaining the grounds around buildings is important i.e. grounds can be uneven and not accessible, ramp in the wrong place with no signage and overgrown planting

#### 3.3 Inclusive Banyule Advisory Committee

Council has been working with the Inclusive Banyule Advisory Committee to identify some high level priorities. These are mental health and social and affordable housing. The committee is now seeking feedback from the population groups on these issues.

What are the key opportunities faced by populations and what opportunities would the population committee like Council to focus on to uplift local mental health supports?

#### Discussion

#### Member feedback

- Exercise and physical activity assist with managing mental health. To alleviate costs which can be unaffordable and therefore prohibitive, Council should look to subsidies and support available to community.
- There should be a focus on improving access and referral pathways for existing programs with subsidised access. I.e. some programs require referral through GP and psychologist but these are hard to access and also cost. Further, people with disabilities may not have the skill sets to research and find opportunities or understand referral pathways to access them.
- Services should deliver multiple approaches that reflect the needs of differing disabilities
- Information needs to be accessible, keeping copies available to the community, with multiple ways to access info large writing, hard copy, braille, online.
- Mental health support services can struggle with co-mobility issues e.g, autism diagnosis and mental health concerns, which can present as a barrier for people in the community in accessing services.
- There should be investment in safe and connected places and communities is important to support people with disabilities to participate.
- Prevention should be the key focus.

What are the key opportunities faced by populations and what opportunities would the population committee like Council to focus on to uplift access to local social and affordable housing?

#### **Discussion**

#### Member feedback

- Rent to buy programs should be offered.
- New social housing builds should incorporate accessibility in their design. Making accommodation which is liveable and suited to individual needs is important.
- Wrap around supports needed to accommodate the needs of residents.
- Community and relevant stakeholders should have a say before decisions are made on housing stock.
- New social and affordable housing developments should consider that people with disability don't necessarily respond well to overcrowded living conditions and may be better suited to smaller
- Friendships keeping people together
- Council having a NDIS expert to support community to help people understand their options

# 3.4 Advisory and population committee feedback

In response to the survey sent at the end of 2022, a total of 36 responses were received from the members across the eight Committees. The key observations made were:

- 1. 5 responses from D&IC
- 2. Positive experience but ways to continue to improve
- 3. Inducting new members
- 4. More opportunities to come together with other committees
- 5. Briefing papers working well
- 6. Accessible agenda is very well received

7. In person meetings – value of conversation is better but also providing opportunities for those than can't be in person due to personal issues

# 4. Standing Agenda Items

# 4.1 Inclusive Banyule Workplan for Disability

A number of key projects are progressing within the Inclusive Banyule Plan. Committee members were invited to comment on items within the workplan via email.

# 4.2 Existing Website

Existing website page for People with Disability is being reviewed and updated. A progress update was provided, with the key point being that information will be adapted to ensure it is up to date and relevant, with the addition of web addresses.

# 4.3 New Disability Website

As per Council Resolution to invest into the development of a new disability website. This agenda item will provide an ongoing update on the status of the project and gain feedback as required. See attached project plan.

#### **Discussion:**

Two distinct phases of the digital project are planned:

**Phase One**: A discovery and options phase to understand more about the needs and challenges of people with disability in Banyule, their families and carers. Recommendations from this analysis will inform Phase Two.

**Phase Two:** The design and build phase of a digital product based on the recommendations from Phase One.

- Council will form a Panel of Experts (internal and external) to feed into the project and will engage the BDIAC as soon as we have more details.
- Council is meeting this week with three potential consultants who could do the user-focussed discovery
  work. Discussions from the last BDIC meeting (December) are being used to guide the selection of the
  consultant.
- A Project Control Group has been established to provide direction to the project and make key decisions as needed. Their first meeting is on Monday 27 February.

#### 4.4 Accessible Communication Guide

Council in partnership with the Brotherhood of St Lawrence is in the throws of community consultation for the development of an Accessible Communication Guide.
