Holi – 25 March

Holi is known as the Festival of Colours and signifies the triumph of good over evil.

Easter – 29 March – 1 April

A principal holiday of Christianity- marks the Resurrection of Jesus.

Eid al Fitr – 10 April

Festival of breaking the fast at the end of Ramadan.

3. Presentation – 6.15 pm – 6.30 pm – Dr Franka Vaughan, Victoria University

Dr Vaughan presented high-level results from the Understanding reporting barriers and support needs of people experiencing racism' research project.

Franka Vaughan is African living and working on unceded lands of the Kulin Nation. She is a Researcher for the Victoria University-led anti-racism project: 'Understanding reporting barriers and support needs of those experiencing racism'. Franka is also a Teaching Specialist in the School of Social and Political Sciences at the University of Melbourne. Her research focuses on race relations in settler states, global histories of race and colonialism, migration and diaspora and antiracism praxis in research and curriculum.

Discussion

- The research looked into barriers and supports needs for those experiencing racism. Wanted to see how the data can help improve existing reporting pathways and improve the anti-racism support services.
- Banyule hosted 4 community forums and collected 56 surveys.
- Most respondents had experienced racism in the last 12 months. In the research, racism was defined broadly including religion, vilification and exclusion.
- In Banyule, the majority of respondents reported experiencing racism at shopping centres and on public transport, this differs from other Local Government Areas where in workplaces was the most common response.
- In Banyule, respondents reported experiencing everyday racism, microaggression and the feeling of being looked down upon.
- Most people who have not experiences racism think they would report it. Only a minority of those who have experienced racism have reported. Therefore not reporting included feeling like nothing would change, no proof and not being taken seriously.
- Respondents reported they would prefer to report incidents in person and others just wanted to do it online. The reason for reporting was to raise awareness.

- People report looking for support and are looking for cultural safety, sensitivity.
- The Victorian Human Rights Commission has a strong focus on conflict mediation, this can be re traumatising within an anti-racism intervention.Discussion item.
- A lot of people are unaware that supports existed. **Next Steps:**
- Victoria University want to work with community networks and find training opportunities to build the capacity of local government staff.
- Investigate ways to work with public transport providers and shopping centres to identify interventions to reduce racism.
- Consider establishing a community-led anti-racism support and advocacy network.
- A lot of people were aware of reporting experiences of racism to Victoria Police but felt that their reports were not taken seriously. Investigate how we can equip community to fill in the reporting gaps.

Questions from the Committee:

- The committee was curious if the survey also collected information about the respondent i.e., age, how long they have been in Australia and whether this is different in findings and languages spoken at home. Dr Franka explained that demographic information was captured. A large amount of data has been captured and the Victoria University team are currently collating reports which will be made available.
- Experiences of racism in schools was captured through the focus group discussion. The older generation reported that things are better now but still microaggressions are still occurring. Racism in schools was one of the main areas where experiences of racism was noted.

4. Consultation – 6.30 pm-6.45 pm – Lee Hannah, Project officer – Library of

Things

The Community Resilience and Health team are currently researching a 'Library of Things' model for the Banyule community. A Library of Things is a place you can go to borrow different types of items you may not use frequently.

Discussion

The committee were invited to comment on items they would be interested in borrowing from the library, other than books.

- Decorations Christmas, Halloween etc
- Slow cooker try one out before buying one
- Camping equipment
- Tools
- Victorian Aboriginal works of art and display in home for set periods of time allow people access to rotating arts
- Seeing library running workshops during COVID library use increased because the libraries introduced new things and products
- Bikes and bike parts
- Subscriptions to software programs
- Movie projectors

- Large pots that can be used for cooking at big events and celebrations
- Skiing equipment
- A 'people' library examples exist in other places where you 'borrow' a person to learn more about their cultural, background, life. This could also include 'borrow a grandparent' for people in Australia who do not have grandparents close by.

Comments from the Committee:

- The Banyule Toy Library only catered for young children; a committee member thought it would be great to have options for older children.
- Local Scout groups own a lot of equipment that sits unused most of the time. Consider opportunity to partner with these organisation and share access to equipment. Consider challenges around how equipment is maintained.
- How do you consider and plan for damage/wear and tear to items borrowed. Does borrowing items incur a fee?
- Will the library allow for borrowing of items used for business to make money.

Action

Cr Castaldo encouraged members of the committee to continue to provide ideas for the Library of Little things to Lisa via email.

5. Inclusive Banyule – 6.45 pm – 7.15pm – Lisa King

Action 2.3 We will review and update the information on Council's website to ensure it is relevant and useful for multicultural

communities.

Council's Multicultural and refugee and asylum seeker webpages will be updated as per an action within Inclusive Banyule. The committee feedback will be incorporated into the plan.

Action

Lisa King will present the proposed wireframe of the website to be shared with the Committee during the June meeting.

Action 2.6 We will promote participation in cultural-based older adults groups in Banyule.

Research into the current state of older adults groups in Banyule with specific emphasis on cultural-based groups has been undertaken.

Council continues to identify barriers and opportunities to support participation in groups.

Action

Lisa King will present the report with the committee during the June meeting.

Action 2.7 We will participate in a research project with Victoria University to understand reporting barriers

and support needs of people experiencing racism.

Preliminary data report for Banyule has been received and the full data report will be made publicly available in July 2024.

Action 2.9 We will continue to elevate visibility and awareness of multicultural communities through events, advocacy and

days of celebration.

Harmony Day

Lisa King to speak to Council's Communications team regarding search navigation not linking directly to the Harmony Day event.

6. Any other business – 7.15 pm – Cr Castaldo

Cr Castaldo raised recent media reports regarding drownings around Australia and what Council can do to improve access to learn to swim programs for members of Banyule multicultural committee.

Action

Lisa King to discuss this topic with Council's Sports and Recreation team and how this can be captured in the new plan.

7. Information share for Committee members 7.15 pm – 7.30 pm - All

The Committee discussed current community feelings following the incident in Sydney and how that impacts and creates tensions in local communities.

The Committee acknowledged that April 14 was Sri Lankan New Year. Puthandu, also known as Tamil New Year, is the first day of the year on the Tamil calendar and is traditionally celebrated as a festival by Tamil People across the world.

Action

Lisa King to discuss with relevant teams to include Puthandu, Tamil New Year, to be added to Council's days of cultural and religious calendar.
