EXECUTIVE SUMMARY

This report is to enable Council to formally hear written submissions received regarding the Proposed Budget 2020/21 and the Proposed Council Plan 2017-2021 (Year 4).

In accordance with the provisions of the *Local Government Act 1989* (the Act) Section 223 gives a person making a submission the right to be heard in support of their submission.

This Special Council meeting is for submitters, under s223, who have requested in their submission that they wish to be heard in support of the submission. Each submitter will, at this Special Council meeting, be provided with the opportunity to be heard and address Council in support of their submissions.

At the Special Council Meeting on 4 May 2020, Council resolved to give notice for the Preparation of the 2020/21 Budget and the Preparation of the Council Plan 2017-2021 (Year 4). Subsequently, Council commenced the public exhibition period in accordance with the *Local Government Act 1989* (the Act).

Copies of the proposed Budget 2020/21 and proposed Council Plan 2017-2021 (Year 4) were made available for community comment from 7 May 2020 to 4 June 2020, enabling members of the community to provide formal written submissions.

Formal submissions were received until close of business on Thursday, 4 June 2020, with forty (40) submissions received in relation to the Budget and Council Plan.

The submissions received are presented in a summary form as an attachment to this report. Full copies of all submissions have been provided to Councillors for their information and review prior to the 17 June 2020 Special Council Meeting.

At the time of writing this report there were Eighteen (18) submitters who have requested, as per their right under s223, to be heard.
