

# Better Score Household Energy Efficiency Upgrade Project Grants

## 2024/2025 Guidelines



# Purpose

**Banyule City Council is committed to supporting the community in working towards carbon neutrality.**

A total of \$75,000 has been allocated for the financial year 2024/2025 to support the delivery of priority action 1.2 from Council's Community Climate Action Plan:

***Examine a range of economic levers to support the uptake of energy efficiency measures for residents and business owners***

The Better Score Energy Efficiency Upgrade Program (the Better Score Program) will offer up to \$1,000 for the implementation of energy efficiency upgrade initiatives identified in the

# Grant pool

The Better Score Program aims to fund a total of up to \$75,000 across all successful applications.

**The maximum an individual grant can be awarded is \$1,000, plus the cost of 2 energy audits and an energy assessor report.**

Eligible upgrades will be funded up to 60% of the total invoice value.

Applications will be open for three weeks with successful applicants chosen by ballot if the program is oversubscribed. Previous recipients of a Better Score grant are not be eligible for the 2024/2025 round.

# Key dates

Late applications will not be accepted.

- 1. Applications open:** 9am, Monday 1 July 2024
- 2. Applications close:** 5pm, Friday 19 July 2024
- 3. Outcome notification:** Within 5 business days after closing.

# Eligibility

## Individual household applicants must:

- Be a Banyule resident (owner occupier or if you are renting, have written approval from the landlord)
- The property is worth less than \$3 million
- Have a combined income of less than \$210,000 per year (based on a Tax Office Notice of Assessment)
- Use funding to undertake upgrades for your primary residence only
- Engage licensed trades to complete upgrade works
- Be willing to complete a Variation Victorian Household Energy Scorecard Assessment after the upgrades have been completed
- Agree to the terms and conditions of the program.

## General terms and conditions:

- Eligible upgrade options must be recommended in the Scorecard Assessment Certificate or the assessor report
- Applicants must supply relevant compliance certificate for all electrical and plumbing work and tax invoices for the completed work as a part of their acquittal
- You agree to share your household energy efficiency scorecard assessment result and the variation assessment result for reporting purposes
- Council may use information from your application for report writing/ case studies
- Hot Water Heat Pumps must contain only low Global Warming Potential (GWP) refrigerants, i.e. below 700 as per Victorian Government's guidelines.
- Council Officers may inspect your upgrade project
- Applicants must ensure all Statutory legal and insurance obligations will be complied for all funded upgrade works
- All upgrades undertaken remains property of the Applicants, Council does not take any ownership nor liability of the funded upgrades
- Applicants must take sole responsibility of the

complete work and liaise with their selected trade professionals for future repair and warranty works.

- Information collected from you is required for the delivery of Council Services in accordance with Council's powers, functions and purposes under the Local Government Act 1989 and other relevant legislation. It may also be used by Council to conduct research and customer satisfaction surveys so that we may better understand community needs and can improve service delivery. ## Applications and supporting documents:

You are required to submit the following documentations as a part of your grant application and grant acquittal:

- A consent form to undertake the scorecard assessment (home energy audit)
- A tax invoice from the qualified trades with upgrade details
- Payment remittance of the paid invoice
- Certificate of Compliance for all electrical, plumbing and gas work
- Photos of completed upgrades (if practical)
- Scorecard Assessment Certificate and Recommendation list
- The Variation Scorecard Assessment

# Definitions

## Scorecard Assessment

Scorecard is delivered by independent accredited assessors using the government-supported Scorecard webtool. The assessor rates the energy efficiency of your home's construction, fixed appliances, and other key features such as solar PV energy production. The Scorecard also rates how comfortable your home is in hot weather.

## Variation Assessment

The process of updating existing scorecard assessment to obtain a new rating certificate after alternation/upgrade works for the property.
